Engagement of Consultants (Forestry & Wildlife) in National Authority

The National Compensatory Afforestation Fund Management and Planning Authority (NA-CAMPA) came into existence on 30th September 2018. National Authority takes up subjects of national and regional importance pertaining to conservation of forest, wildlife & biodiversity; enhancement of ecosystem services, and research programmes relevant in the field of forest and wildlife. In this regard it is also required to maintain and process the data and information for planning, monitoring and evaluation. National Fund also supports large scale urban greening programme in various cities across the country. The monitoring and evaluation of CAMPA activities throughout India ensures accountability and is one of the pivotal tasks by National Authority. It supports upgradation of technologies used for assessment of green cover through e-Greenwatch and Digital Web- Portal.

The National Authority invites applications from eligible candidates for engagement of Consultant (Forestry & Wildlife) on contract basis initially for a period of one year, which may be extended after review of the performance of the incumbent.

The details of vacancy including the eligibility criteria, Terms of Reference (TOR) etc., are as under:

Consultant (Forestry and Wildlife) - 01 post

I. Duties and Responsibilities:-

- a. Assisting the National Authority in examining the Annual Plans of Operation (APO) received from the States and monitoring of CAMPA activities and expenditures;
- b. Assisting the National Authority in compilation and analysis of data of CAMPA activities and schemes implemented from State CAMPA Fund and National Fund;
- c. Assisting the National Authority in appraisal of schemes and CAMPA activities;
- d. Assisting the National Authority in identification and assessment of areas in designing of new schemes and providing necessary data and research support;
- e. Facilitation and coordination of consultation meetings, workshops and seminars on forestry and wildlife matters;
- f. Organizing meetings, workshops etc. and coordinating with State CAMPA and other organizations;



- g. Any other work assigned by the CEO, National Authority.

II. Qualification and Experience:-

Essential:-

- a. Master's Degree in Forestry/ Forest Management/ Wildlife Management from a recognised university;
- b. 5-10 years of experience of working in forestry/wildlife related projects;
- c. Knowledge of policies and legislation relating to forests, wildlife and biodiversity conservation;
- d. Proficiency in computer operations and MS office applications;
- e. Strong written and verbal communication skills.

Desirable: Ph.D in Forestry/ Forest Management/ Wildlife Management from a recognized university.

Or

A retired forest officer of the Indian Forest Service having experience working in field.

III. Age Limit: Not above 45 years (63 years in case of Retired Government Officer) on the date of advertisement.

IV. Consolidated remuneration: Rs.80,000/- per month.

However, in case of retired Government Servants a fixed monthly amount shall be admissible as per the extant rules, orders and guidelines of the Government of India, arrived at by deducting the basis pension from the basic pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of contract. There will be no annual/percentage increase during the contract period.

V. Terms & Conditions of Engagement:

- i. The appointment of the above Consultants will be of a temporary (non-official) nature and can be cancelled at any time by the CEO, National Authority without assigning any reason.
- ii. Absence from duty for a continuous of 8 days without any information shall lead to automatic termination of contractual agreement.
- iii. Other conditions of engagement of the Consultants will be as per guidelines issued by the Ministry from time to time in this regard.
- iv. They will be governed by the Official Secrets Act, 1923, as amended from time to time and will not disclose to any unauthorized person(s) any information/data that may come to their notice during the period of their engagement as 'Consultant' in the Ministry. All such documents will be the property of the Government.
- v. They will not utilize or publish or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of their assignments or during the course of, assignment for the NA-CAMPA without the express written consent of the NA-CAMPA.



- vi. The Intellectual Property Rights (IPR) of the data collected as well as deliverables produced for the Department shall remain with the Department.
- vii. They will maintain highest standards of integrity, transparency, competitiveness, economy and efficiency while working as consultant in this Department. The Consultant so appointed shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Department nor will they indulge in any activity outside the terms of the contractual assignment.
- viii. Consultant shall not be entitled to any kind of allowance or accommodation facility. However, should they require to travel inside the country in connection with the official work of the National Authority, TA/DA as admissible to a Consultant will be paid to him/her after obtaining approval of the competent authority.
- ix. Tax Deduction at Source (TDS):- TDS as admissible shall be deducted from the monthly remuneration of Consultant. A TDS certificate shall be issued by the concerned DDO on demand.

VI. Procedure for Selection: The Screening Committee constituted in the National Authority/ MoEFCC will scrutinise the applications and select Consultant based on the eligibility criteria as stated above.

VII. Termination of Consultancy: The engagement of Consultant can be terminated by the CEO, National Authority at any time without assigning any reason thereof. However, Consultant will have to give 30 days' advance notice or remuneration in lieu thereof before resigning from the engagement.

VIII. How to apply: Interested candidates fulfilling the requisite qualification and experience may apply and send his/her application through email to **nationalcampa-moefcc@gov.in** in the prescribed application form (Annexure-I) along with CV and all supporting documents (photographs, qualification, experience, PPO, references) **latest by 21st February, 2025 till 05:00 PM.**

The National Authority reserves the right to accept or reject in part or in full or all the responses without assigning any reason whatsoever. Only candidates whose candidature has been provisionally accepted shall be called for interview. No TA/DA will be provided for appearing for the interview. Incomplete applications or applications received after the due date will be rejected.
