- Strict economy should be observed so as to keep the actual expenditure to the minimum. х, The works are to be executed as per the Sanctioned Schedule of Rates applicable in the area.
- The expenditure is to be incurred as per the allocation of funds. If the implementing xi, agency does not use the fund for the purpose for which It was given, it has to refund the same with interest.

The accounts of the Forest Fire Prevention & Management Scheme shall be open for 6. inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 and internal audit party by the Principal Accounts Office of the Ministry whenever it is called upon.

In accordance with the revised procedure the Reserve Bank of India may please be 7. advised to pass on the credit to the Central Accounts Section, Nagpur for transferring the funds to the accounts of Government of Madhya Pradesh and to debit the amount to the Account of the Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi.
