2. The Terms of Reference of the of the Technical Review Committee would be:

- i. The Committee shall meet as and when required to examine proposals received in this Ministry where there are disputes/clarifications required relating to the classification of hazardous and other wastes and other related matters on management of hazardous waste and give recommendation to this Ministry for consideration.
- ii. To examine and recommend the cases of import and export of hazardous and other wastes where MOEFCC desires to have the opinion of TRC.
- iii. Any other issue pertaining to the management of hazardous and other wastes.
- iv. If need be, the Committee will make site visit for on the spot assessment of the related environmental issues.
- v. The Committee may co-opt other members, if need be.
- 3. Payment of TA/DA to the Chairman/ members of the Committee/ co-opted member for attending its meetings and site visits shall be governed as under:
 - i. Chairman is entitled for the reimbursement of the cost of Air travel by Executive Class by shortest route, if any. All other members are entitled to travel by Air in the Economy class by the shortest route subject to production of boarding pass for actual use of the facility.
 - ii. Payment of sitting fee/honorarium @ Rs. 6000/- per day with a ceiling of 10 days in a month for attending the aforesaid meeting by non-official members. Payment of sitting fee to salaried persons employed in Central Universities/UGC/Central Institutions

and autonomous bodies wholly or substantially funded by the Central Government shall not be paid sitting fee.

iii. TA/DA to non-official members will be regulated as per SR 190.

- iv. TA/DA entitlement for non-official members of the Committee will be in accordance with O.M. issued by DoE vide O.M. No. 19047/1/2016-E.IV dated 14th September, 2017 as amended time to time.
- v. Entitlement shall be restricted to actuals.
- vi. Relaxation for air journey, if any, will be as per instructions issued from time to time by the Ministry.
- vii. Air tickets shall be purchased directly from Airlines (at booking counters/office/website of Airlines) and if needed, by utilizing the services of three Authorized Travel Agents viz. M/s Balmer Lawrie & Company Limited, M/s Ashok Travels & Tours and M/s IRCTC.
- viii. There shall be no duplication in payment
 - ix. Payment shall be made through e-transfer only.
 - x. The tenure of the Committee shall be for a period of three years from the date of issue of this Order.
- 4. This issues with the approval of competent authority and with the concurrence of IFD vide their Dy No. E-106222/JS&FA/Note#44 dated 15/04/2022.
